Augusta Locally Grown promotes growing a more robust local food system throughout the Central Savannah River Area.
Our efforts include creating and managing farmers markets, cooking education programs, gardening education programs, farm
volunteer days, new farmer networking, nutrition education, healthy food access in low-income areas, local food events, and
connecting farms to chefs and schools, all with a focus on local agriculture as foundational to a healthy, vibrant community.

1) THE ALG ON-LINE FARMERS MARKET is the first, direct farm-to-consumer farmers market in the Augusta area, with pick-up locations in two counties. This market is a service to local farmers in that it significantly streamlines the market process for more effective use of time and resources for farmers. In 2018, the on-line farmers market included about 35 vendors, some of them new to farming and/or farmers markets. As such, Augusta Locally Grown also provides a service to new farmers, helping them learn and work within the county, state and federal guidelines for food safety and organic practices. This market runs year-round.

2) THE VEGGIE PARK FARMERS MARKET is a traditional, direct farm-to-consumer market in a low-income inner-city neighborhood of Augusta called Harrisburg. It is the only farmers market in Augusta that accepts and doubles EBT/SNAP, in partnership with Wholesome Wave Georgia. This farmers market has a significant educational component, including free cooking demos, free childrens healthy food education, free gardening advice and free transportation from Good Neighbor Ministries. The market is run by community members from the neighborhood, along with volunteer students from the Medical College of Georgia. This market completed its sixth year in 2018.

4b (Code:) (Expenses \$ 74,971.67 including grants of \$ 31,135.00) (Revenue \$ 46,465.31)**EDUCATIONAL PROGRAMS:** In 2018, Augusta Locally Grown conducted a wide variety of educational and healthy food access programs targeted at a wide audience, with extensive efforts made to make local produce more affordable and accessible for all income levels. This included:

- 1) VEGETABLE GARDEN EDUCATION**-in partnership with Helms College, Richmond County Public Health, Golden Harvest Food Bank
- 2) SEASONAL FOODS COOKING EDUCATION** - in partnership with Icebox Urban Farm, Augusta District Dietetic Program, DPH
- 3) YOUTH GARDENING & COOKING EDUCATION** - in partnership with the Boys & Girls Club, Jessye Norman, Westabou School
- 4) FRUIT & VEGGIE PRESCRIPTION PROGRAM** - in partnership with Wholesome Wave GA, Harrisburg Family Health Care
- 5) FARM TOURS & EVENTS** - in partnership with local farmers, chefs and volunteers
- 6) LOCAL FOOD EVENTS** - in partnership with civic organizations including Georgia Organics and Augusta TEDx
- 7) LOCAL FOOD WORKSHOPS** - in partnership with the Clubhou.se, Icebox Ministries, White Hills Farm
- 8) OUTCOMES STUDIES** - in partnership with DPH, Augusta University, Emory University and Wholesome Wave Georgia

4c (Code:) (Expenses \$ 3942.50 including grants of \$ 0.00) (Revenue \$ 0.00)**STUDENT INTERNSHIP & VOLUNTEER PROGRAMS:** In 2018, voluntarism and education continue to be the driving force behind the efforts of Augusta Locally Grown.

- 1) HIGH SCHOOL STUDENT INTERNS** - Our high school intern program involved G students who help run our farmers markets, host special events, assist with educational programs and help in a wide variety of farm-based and community-based projects of their choosing. Those who commit to help our farmers market receive a small stipend.
- 2) UNDERGRAD AND GRADUATE STUDENT INTERNS** - We provide a preceptorship to post-graduate nutrition students through the graduate program at Augusta University; we provide a preceptorship to horticulture students at Augusta Tech; we provide a semester-long undergraduate class in Culinary Horticulture (Biology 101) at Helms College for culinary students; and we provide internships for undergrads from a variety of disciplines based a variety of local universities including USC-Aiken and UGA-Athens.
- 3) MEDICAL STUDENT VOLUNTEERS** - We provide multiple experiences for students from the Medical College of Georgia to address nutrition disparities, with a focus on addressing diet-related illnesses through our farmers-market based and garden-based programs.
- 4) COMMUNITY VOLUNTEERS** - We provide many experiences for community volunteers to get involved in local food activities.

This ruling requires that farmers markets issue 1099s to vendors when their sales exceed \$20,000 and 200 transactions in number during the fiscal year. Given that our efforts are weekly, the 200 transactions test is never met. Our Farmer Handbook states that vendors are responsible for reporting their own sales and incomes taxes.

Part V, 14b - Statements Regarding Other IRS Filings and Tax Compliance - Our organization has no use for tanning beds nor such services.

This 990 and its schedules were presented to the Board of Directors for final review on November 7, 2019. It should be note that ALG changed over to an accrual system AND began using Quickbooks for the first full year in 2018. In the process, Kim Hines discovered a bookkeeping error from a prior 990 and reported it to the Board on Nov 7, 2019.

As such, an amendment to the 2017 990 will be forthcoming. (See explanations below for Part X 1 & 4, and Part XI 8.)

Part VI, 12c - Policies - The organization underwent a revision to of its bylaws during the year 2017 to ensure that organizational policies at the farmers markets that we service are not governed by those who participate as vendors in those markets. That bylaw was finally ratified by the Board of Directors on March 19, 2018. As a result, no farmers (or other farmers market vendors) may sit on Augusta Locally Grown's Board of Directors if they are active vendors in our farmers markets. However, farmers may sit on and advise committees to advise the Board on issues requiring their expertise.

Part VI, 15b - Policies - Our Board of Directors is mindful of the fact that conflicts of interest may arise when discussing issues that pertain to our farmers market policies and activities. As such, it is understood that board members who may be impacted by these policies abstain from a vote or a discussion of issues that would potentially advantage or disadvantage those board members or others.
