28 Movement Exchange unites dance and service, addressing the lack of accessible dance education in underserved communities while providing an avenue for dancers to give back. In the United States our university chapters provided accessible dance education in their local communities, offering free dance classes to individuals in youth foundations, foster care centers, domestic violence shelters, and more. In Panama we hosted international dance exchanges year-round and provided dance education programs at orphanages and foundations. We held our 9th annual theater show in Panama when 60 students and 8 dance diplomats performed together on stage. In Brazil we had our 2nd annual dance exchange to Rio de Janeiro where participants taught at youth foundations and discovered the rich culture of Brazil. In 2018 we provided free dance education to 3,923 youth throughout the United States, Panama, and Brazil, and our community of dance diplomats donated 10,300 hours towards providing arts education to underserved communities and international dance exchanges aimed at fostering cross-cultural understanding. With 374 chapter members, Movement Exchange's network of dance diplomats continues to expand across the United States.
