Reporting Starting in 2012, Investigative Post began reporting on corruption in the awarding of contracts to build the Tesla plant in South Buffalo. Then U.S. Attorney Preet Bharara cited our reporting in announcing criminal indictments in the case. In 2018, several of those indicted plead guilty and others were convicted. Our investigations into the drowning death of Buffalo Police Officer Craig Lehner while on a training drive documented that the water he was diving in was unsafe and that he had not received proper training and equipment. The City of Buffalo is failing to enforce its fair housing law, leaving low-income residents at the mercy of landlords who don't want to rent to tenants with Section 8 vouchers. The Western Regional Off Track Betting Corp. is providing its part-time board members with gold-plated health, dental and vision insurance despite a legal opinion from the state Attorney General that they aren't entitled to such benefits.

Environmental We've broken a number of important environmental stories. Noteworthy pieces include: City of Buffalo has failed to enact any of the reforms recommended more than a year ago to address lead poisoning in the inner-city. The story is part of our long-term commitment to shed light on this problem. Former American Brass plant in Black Rock has been cited for violations by EPA and OSHA. An examination of a proposal to construct wind farms in Somerset and Yates. (The project was subsequently shelved.) We also have been discussing an initiative with our trade group, the Institute for Nonprofit News, to collaborate with a number of other nonprofit newsrooms to produce stories related to the Great Lakes. This remains a work in progress.
