The Green Urban Lunch Box is a community food production agency engaging the community in local production to make fresh food accessible and affordable. The Green Urban Lunch Box's mission is to empower people to engage in local food production, to use resources available in their community in new and creative ways. Working in the middle of Salt Lake City's urban landscape, we are challenging ourselves and our city to look at natural resources, food systems, and community involvement in innovative ways.

The Back-Farms project is an ongoing yard-sharing initiative that connects low-income, elderly homeowners with local volunteers, who work together to convert surplus backyard space into productive urban farms. Through the local volunteers' hard work and the land resources, we help transform underutilized yards into fertile, food-producing gardens. A head gardener trained in organic practices and effective high-desert growing techniques supervises all participating gardens. During the weekly gardening sessions, the elderly homeowners and volunteers form lasting, nurturing relationships while also beautifying Salt Lake neighborhoods and producing healthy, local food. The food harvested is shared among the homeowner, the volunteers, and at free Farmers Markets held at local Senior Centers. Back-Farms serves the community in many significant ways. Our organization provides fresh produce to citizens in need by growing food in otherwise unused backyard spaces. It also operates as an incredible educational tool to the community. The benefits of the garden are felt not only by the homeowner, elderly and/or disabled men and women whose access to fresh produce is severely limited, but also to the community as a whole. Back-Farms also frequently facilitates an intergenerational connection between the plots' volunteers and the homeowner. This program facilitates a connection between gardener and consumer, breaks down social barriers, provides food to people in need, as well as provides an opportunity for seniors to give back to their communities.

FruitShare engages community members to volunteer to harvest fruit at local homes and in abandoned orchards, creating a win-win solution for all involved. Rescuing fruit that would fall on the ground and go to waste, relieve the burden of the harvest on the homeowner, and provide locally grown fruit to people with limited access. The harvest is split 3 ways between the homeowner, the volunteer, and local hunger relief. FruitShare also offers a solution to the many families who do not have the time or resources to care for their tree or utilize the hundreds of pounds of fruit produced in a single season. When left unpicked, a majority of the fruit rots on the ground, creating a mess for the homeowner to deal with. As a result, many homeowners tire of the time-consuming and arduous year clean up and elect to have the tree cut down to solve this problem. Tree removal eliminates this valuable source of food, clean air, and CO2 removal. It also further decreases species diversity, which is essential to the stability of our food system and future food security as we deal with climate change.

SFI is our urban farmer training program that aims to increase the number of successful local farmers in Salt Lake County. The central purpose of SFI is to provide participants with the technical skills, entrepreneurial acumen, and hands-on experience required to start successful small farm businesses. The program, based at our three-acre Community Farm in South Salt Lake, is built specifically for low to moderate income individuals in Salt Lake City.

The courses involve weekly classroom sessions on agricultural and business subjects, along with on-going, hands-on experience in the appropriate area of study. The courses range from 24-40 weeks in length, and require a 5-20 hour weekly commitment. All food grown is distributed at low cost markets in a local food desert and donated to hunger relief organizations.
