Deaf Can receives a grant from Alcohol and Drug Abuse Division under Minnesota Behavioral Health Division to provide sober housing and support services to adults who are Deaf, Hard of Hearing or DeafBlind and are recovering from substance use disorders. The program model aims to help the client maintain stabilization of biological, psychological and social functioning in the community; to promote a positive and healthy lifestyle; and solidify gains accomplished in treatment. The design of the project is to find safe and sober supportive housing in the community and hire qualified Sober Coaches to provide housing support services to deaf adults 18 years and older who have completed primary treatment from the Minnesota Chemical Dependency Program for Deaf and Hard of Hearing Individuals (MCDPDHII). \$127,000 annual fiscal year grant is used for facility, equipment, and staffing costs. Sober Coaches provide instruction covering communication skills, community resource utilization skills, relapse prevention skills, employment skills, health management and basic living skills.

Outcome measures reported to the state will focus on housing stability, increased skills or income; and greater self-determination. This program is called Deaf Living Sober (also known as DLS).

Deaf Can provides Home and Community Based Services (HCBS) for people with disabilities and those ages 65 and older. This program is licensed by Minnesota Department of Human Services under Minnesota Statutes, chapter 245D passed by the 2013 Minnesota Legislature. We are eligible to provide services statewide that include: Independent Living Skills (ILS) training, Homemaker (Tier 1) services, and Adult Companion services. Funding to pay for services is arranged by the individual's county social worker who develops a service agreement that details what type and how much services is needed for that person. Other options and sources to pay for this fee-for-service are available.

This program is called Deaf Outreach Services (also known as DOS).

Minnesota Behavioral Health Division allows for their grant funds to be used for client related expenses. The types of approved expenses and guidelines for use are defined in the grant's Request for Proposal (RFP) and contract agreements. The categories are Client Transportation, Client Housing, Client Incentives, Client Emergency Funds.

Deaf Can staff would assess the financial needs of the clients being served and work with the client to access and apply for public assistance funding sources in order to meet their needs.

In the event that there are no public assistance available or if there is not enough money to support the client, the client will make a written request to the business manager. The request must include these details: the amount needed and purpose for the request. The client shall explain attempts to find other solutions and the results before deciding to make the request.

The business manager will follow up with the client and direct service person to verify the facts and then determine the validity and benefit of awarding financial assistance.

Client Transportation includes bus and taxi fares or other modes of transportation. Client Housing includes rent assistance, security deposits, equipment needed for safety of residents.

Client Incentives are used to promote sobriety and meeting program objectives. Assistance includes food, personal needs, social activities, and gift cards. Gift cards are prices at no more than \$20 each and cannot be used for purchasing alcohol, tobacco, licit or illicit drugs, including energy drinks. Client Emergency Funds are used for clients who are transitioning from temporary living situations or shelters into more permanent housing. That includes personal needs and food supplies, additional furniture for their apartment.
