Delivered five multi-day leadership programs in the US, three conference workshops and six virtual programs including general Zen leadership programs and programs targeted for health practitioners (HEAL). More than 120 people were served by these live programs and workshops, and well more than 1000 attended the virtual programs this year. Further certified 19 coaches to work with the mind body personality instrument, FEBI, that is used in our IZL programs.

Delivered five multi-day Zen and leadership programs in Vietnam and the UK, including a program for 80 leaders running a conference center which will likely be a site for future Zen leadership programs. Also completed the Zen leader trilogy of programs with the managers of Golden Hearts, the company that hosts IZL programs in Vietnam, and taught Zen Leader 1 and 2 in the UK. More than 170 people were served by these events.

Provided funds and administrative support to our sister organization, International Zen Dojo of Wisconsin, a 501c3 church, for programs in Zen training and the development of Zen leadership instructors, per our mission.
