OVER 150 GUJJAR GIRLS ARE RECEIVING AN EDUCATION AND ADULTS ARE BECOMING LITERATE FOR THE FIRST TIME IN THESE MOUNTAINOUS, REMOTE COMMUNITIES.

SKILLS DEVELOPMENT TRAINING WAS CONDUCTED IN THE FALL OF 2018 BY LITERACY CONSULTANTS WITH PLANS TO DEVELOP TWO ADDITIONAL BOOKS IN 2019.
