WHEN HOUSE OF HOPE INTERNATIONAL DISPERSES FUNDS TO HOUSE OF HOPE NICARAGUA EACH AMOUNT IS RECORDED AND NOTED BY THE EMPLOYEE THAT IT IS GIVEN DIRECTLY TO. ALL FUNDS GIVEN TO THE DIRECTOR, THE MAINTENANCE CONSTRUCTION MAN, OR OTHER STAFF MEMBERS OTHER THAN THE STAFF ADMINISTRATOR ARE MONITORED BY THE STAFF ADMINISTRATOR. YAHAIRA MEETS REGULARLY WITH THOSE STAFF MEMBERS AND GETS RECEIPTS FOR ALL MONEY SPENT AND ANY RETURNED MONEY THAT WAS OVER OR MAKES PAYMENT FOR ANY LACK BECAUSE PRICES WERE BIGGER THAN ESTIMATED. YAHAIRA ENTERS ALL THE RECEIPTS INTO QUICKBOOKS. MOST OF THE RECEIPTS ARE CASH RECEIPTS IN CORDOVAS, THE NATIONAL CURRENCY. APRIL, THE INTERNATIONAL DIRECTOR HANDLES AND CHECKS EACH RECEIPT ENTERED INTO QUICKBOOKS IN US DOLLARS. WE HAVE A TWO PARTY SYSTEM FOR ACCOUNTABILITY.

WE HAVE A NICARAGUAN ACCOUNTANT ON RETAINER WHO THEN SUBMITS ALL FINANCIAL PAPERWORK TO THE NICARAGUAN GOVERNMENT AND PERFORMS A YEARLY AUDIT.

IN HONDURAS, THE NATIONAL DIRECTOR, MERCEDES, RECEIVES FUNDS DIRECTLY FROM THE INTERNATIONAL DIRECTOR EITHER BY CASH IN HAND OR BY WIRE BANK TRANSFER. SHE THEN DISPERSES THE FUNDING BY PAYING OTHER STAFF MEMBERS, AND PURCHASING NEEDED SUPPLIES. SHE THEN MEETS WITH APRIL HAVLIN, THE INTERNATIONAL DIRECTOR AND TURNS IN ALL RECEIPTS. YAHAIRA, THE STAFF

WE HAVE A VOLUNTEER PROFESSIONAL ACCOUNTANT IN HONDURAS WHO OVERSEES THE PROCESS AND TURNS IN THE NECESSARY FINANCIAL STATEMENT TO THE HONDURAN GOVERNMENT EACH YEAR.

THE PROGRAM IN BOLIVIA IS MUCH SMALLER. THROUGH THE BAKERY THAT HOUSE OF HOPE INTERNATIONAL HELPED THEM TO SET UP, THEY GENERATE A LOT OF THEIR OWN

FUNDING. ALSO, THE CHURCH THAT THEY ARE UNDER THE UMBRELLA OF, PROVIDES A LOT OF DONATIONS IN KIND FOR THE WOMEN AND CHILDREN WHO LIVE IN A RESIDENTIAL PROGRAM AND SOME INGREDIENTS FOR THE BAKING PROGRAM. HOUSE OF HOPE INTERNATIONAL WORKS ALONGSIDE THEM. FROM APRIL 2014 UNTIL JULY OF 2020 WHEN SHE PASSED AWAY, NELVY, THE NATIONAL DIRECTOR FOR BOLIVIA, MOSTLY HANDLED THE FUNDS DONATED TO HOUSE OF HOPE. SHE KEPT TRACK OF THE EARNINGS FROM THE BAKERY BUT THAT WAS COMPLETELY SEPARATE FROM HOUSE OF HOPE INTERNATIONAL.

ALSO, CYNTHIA, THE CHURCH ADMINISTRATOR, WOULD ADMINISTER THE SALARIES TO THE EMPLOYEES AND FUNDING FOR CONSTRUCTION PROJECTS. APRIL HAVLIN, THE INTERNATIONAL DIRECTOR, WOULD MEET WITH CYNTHIA AND REVIEW ALL RECEIPTS FROM CONSTRUCTION AND STAFF PAY.

NELVY HANDLED ALL THE FUNDS FOR DAY-TO-DAY RUNNING OF THE PROGRAM AND HELPING THE INDIVIDUAL WOMEN AND CHILDREN. NELVY WAS A VOLUNTEER.
