GPF has been instrumental in the relocation of 87 rhinos from South Africa with the relocation into the Botswana wilderness. There are 3 core breeding herds and over the past 4 years 35 new calves have been born. The program cover the full cost of pre-trans-location quarantine costs, all licence and permit applications, the actual transportation costs, release cost and post release security and monitoring costs. The Foundation covers the cost of two monitoring teams who are based close to the breeding herds, the costs of a central monitoring station, telemetry equipment and satellite tracking of the rhinos. This has ensured that the herds are managed and if necessary relocated away from high risk areas. Poaching risk has risen in the last year in Botswana and the constant on the ground monitoring combined with aerial observation and satellite tracking has significantly reduced the threat. In addition the monitoring teams consistently engage with the community to educate them on the benefits of a diverse wildlife population and the commercial benefits which flow from employment opportunities in the tourism sector.

4b (Code:) (Expenses \$ 23,162 including grants of \$ 0) (Revenue \$ 135,704)**Land for Lions**

Land for Lions is focused on securing extended areas for lion and big cat populations in the wild. This involves a multi focused initiative developing relationships with the communities, educating communities and growing the area of influence we have in this area. In 2018 we supported the successful hosting of the 3rd Maasia Olympics in December 2018.

4c (Code:) (Expenses \$ 130,753 including grants of \$ 0) (Revenue \$ 130,753)**Anti Poaching Initiatives - Greater Zambezi River Valley**

In 2017 GPF commenced an initiative in association with the Zimbabwe National Parks Authorities to combat poaching in the Greater Zambezi River Valley. The Foundation funds the capital investment of having a team in the field including camp accommodation, vehicles and equipment and the operating expenditure by way of salaries, staff rations and welfare and uniforms. This has had a huge impact on the reduction in poaching in the area in particular elephants and game meat. The Foundation covers the cost of 12 National Park ranger costs as well as the conservation manager.

The Foundation uses donations received to acquire the rhinos, quarantine the rhinos and transport the rhinos into pre agreed release sites. Post release the project employs a team of dedicated rhino monitors who patrol the rhino in the wild ensuring their safety and security. Each translocation is treated as a mini project with the budget pre agreed upfront. Cost disbursements are managed against the agreed budget. The budget includes capital equipment, human resources and ongoing veterinary care of the animals. The project co-ordinator reports both to a steering committee of the Foundation and to the National Rhino Co-ordinator in Botswana as well as the Minister of Tourism and Wildlife.

To date 87 rhinos have been translocated into the wild with a total of ³⁵~~22~~ calves born in the wild.

At the time of release we provide for the full 3 year post release security and monitoring costs.

Part IV Line 1 DR Joubert is the CEO of Great Plains Foundation and Great Plains Conservation ("GPC") & a director of Linyanti Explorations

As a shareholder of GPC, Mr Joubert has an indirect holding of 19.24% of the issued shares of Linyanti Explorations, this company provides management and purchasing services for the security and monitoring of rhinos released into the Botswana wilderness as well as other GPF projects. There is no charge for these services but all direct costs in relation to the project are charged to GPF and paid at cost.

Part IV Line 2 In 2018 Linyanti Explorations held a fund raising event for GPF and raised a net amount of \$38,464.

Part IV Lines 3, 5, 8 and 10 These companies are subsidiary companies of GPC. DR Joubert is therefore an indirect shareholder and director of these companies. As part of the marketing strategy the GPC companies levy a conservation charge on their bookings. All amounts received are either paid to GPF or held for account of GPF to cover direct costs incurred on behalf of GPF.

Part IV Line 6 DR Joubert has an indirect shareholding of 8.26% in the equity of Great Plains Sapi Concession ("GPSC") and is a director of this company. GPSC provides purchasing services and administration services for the anti-poaching initiative in the Greater Zambezi River Valley. There is no charge for this service and all direct costs in relation to the project are charged to GPF at cost.

Part IV Line 4 DR Joubert is a director of Banoxi (Pty) Ltd. The RWB rhino monitoring staff have contracts of employment with Banoxi (Pty) Ltd and the full cost of these employment contracts including statutory benefits accruing under Botswana employment legislation is charged to GPF and paid at cost. The company also pays direct costs on behalf of GPF and recovers these at the actual cost.

This has had a huge impact on the reduction in poaching in the area in particular elephants and game meat.
