Explanation: THE SIOUX FALLS ARTS COUNCIL RESPECTFULLY REQUESTS ABATEMENT OF THE LATE FILING PENALTY AND INTEREST OF ITS FORM 990-EZ FOR THE YEAR ENDED DECEMBER 31, 2018 BASED ON REASONABLE CAUSE.THE SIOUX FALLS ARTS COUNCIL ("SFAC") HAS A VOLUNTEER BOARD. DURING 2018, THE ORGANIZATION EXPERIENCED SIGNIFICANT BOARD TURNOVER, ALONG WITH A CHANGE IN EXECUTIVE DIRECTOR AND BOOKKEEPER. THE PAST PRESIDENT HAD TAKEN RESPONSIBILITY FOR FILING OF THE RETURN IN 2017 AND PRIOR YEARS WITH THE HELP OF THE BOOKKEEPER. THE NEW PRESIDENT WAS NOT ACCUSTOMED TO HAVING THIS RESPONSIBILITY. IN CORRESPONDENCE WITH THE ACCOUNTING FIRM THAT PREPARES THE RETURN, THE NEW PRESIDENT MISUNDERSTOOD THE DUE DATE OF THE RETURN AND MISTAKENLY BELIEVED THE INFORMATION WAS DUE TO THE ACCOUNTING FIRM SO THAT IT MAY BE COMPLETED ON OR BEFORE DECEMBER 31, 2019.THE FAILURE TO TIMELY FILE WAS NOT DUE TO WILLFUL NEGLECT, BUT RATHER DUE TO A MISUNDERSTANDING BY THE VOLUNTEER RESPONSIBLE FOR ITS FILING.THE SFAC HAS HIRED AN EXECUTIVE DIRECTOR, WHOSE JOB DUTIES INCLUDE COORDINATING WITH ITS BOOKKEEPER AND ASSURING TIMELY COMPLIANCE WITH TAX FILING DEADLINES. IN ADDITION, THE BOARD IS IN THE PROCESS OF CREATING A STANDING FINANCE COMMITTEE, WHOSE MEMBERS WILL COORDINATE WITH THE EXECUTIVE DIRECTOR AND ESTABLISH ANY ADDITIONAL CONTROLS, AS NEEDED, TO ASSURE THAT THIS DOES NOT OCCUR AGAIN.AS THE PRESIDENT OF THE SIOUX FALLS ARTS COUNCIL, I ATTEST THAT THE INFORMATION PROVIDED IN THIS STATEMENT IS TRUE AND CORRECT.SIGNED: ALEX M.
