We worked with more than 6,000 young entrepreneurs to create almost 6,000 jobs.

Loan funding to entrepreneurs - AEC provides financing at below-market rates to young entrepreneurs, so that these funds can be used to grow their businesses to create jobs. With backing from Kiva, these loans are made with the support of crowd-funding investors, and is a line of credit for AEC. These loans are within our charitable scope as most young people are not able to access the financing required to meet their goals from traditional means (like banks).
