The weekend offered a free two-day Foundation for Women's Cancer Survivors Course featuring talks from nationally recognized gynecologic oncologists coming from all over the United States, support groups, experiential learning and breakout workshops for gynecologic cancer survivors, family and friends, doctors, care takers and other members of the medical community. In addition, Let Every Woman Know hosted a First Friday Art Showcase at Blue Hollomon Gallery featuring works by artists whose lives have been touched by cancer, and a Saturday night Dance Like Barb Rhythm Heals Benefit Concert at Taproot. 100% of all weekend event proceeds go towards funding the many Let Every Woman Know programs throughout Alaska.

The Alyeska Climbathon is part of an international movement for gynecologic cancer awareness and a fundraiser for Let Every Woman Know - Alaska and the Girdwood Health Clinic. The 2018 Alyeska Climbathon had 303 climbers churn out 1,172 laps over the course of 10 hours to support the movement to create awareness and education of gynecologic cancers. Let Every Woman Know distributed awareness cards and posted information on the signs and symptoms of GYN cancers so that all participants and observers were well informed.

The EXTRA-TOUGHS is an exciting program founded by Let Every Woman Know Alaska to provide an integrative team approach to sustainable weight loss, healthy lifestyle, and survivorship for gynecologic cancer and breast cancer survivors. This group is limited to women who fit the following criteria: 1) Diagnosed with a breast and/or gynecologic cancer 2) Completed primary treatment (i.e. surgery, chemo, radiation) 3) Body Mass Index (BMI) ≥ 30 . This program includes custom designed group fitness exercise three-times a week, weekly support groups with fellow EXTRA-TOUGHS to address successes and challenges together and weekly nutrition classes to learn healthy eating habits. In 2018, the EXTRA-TOUGHS had four 12-week cycles with a total of 9 new starts to the program and 12 returning ladies.
