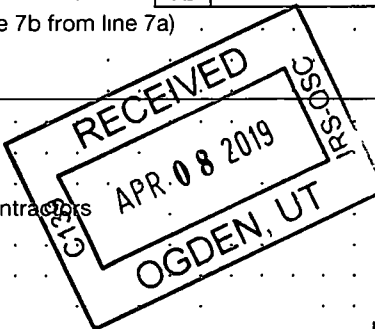



These expenses are the cost of operating Camp Alihpomeh, a camp for boys with bleeding disorders in Texas
