 Clawson Soccer's purpose is to teach the game of soccer and good sportsmanship to youths age 19 and under, to provide a program to prevent juvenile delinquency by providing opportunity for young people to learn and play soccer, to manage and conduct excursions and social meetings and organized team play within and/or outside the state of Michigan. Recreational Soccer is a community-based program that facilitates in-house games for our U4-U6 players and recreational games with neighboring communities for our U7-U19 players. Clawson TopSoccer (The Outreach Program for Soccer) is a community-based training and team placement program for young athletes with physical and mental disabilities. Strikers SC provides advancement of player development through experienced coaching and training in a competitive environment. We do not focus solely on game results, but the long-term development of the player and team.
