Education The preschools continue to grow in numbers serving over 300 of the poorest children in the region free of cost The "Bowl of Porridge" continues to be an important nutritional part of the day along with lessons in numbers, letters and English language The preschools are preparing the children for success when they attend elementary school The third class of students of Kivu Hills Academy enrolled in 2018 and the school served 140 students of which 35% were girls This is an important achievement as girls culturally do not receive training or employment in the trades In addition to the trade of plumbing, electricity, carpentry, masonry and computer science the school added tourism and brick making to the curriculum with a fully equipped workshop With their new skills, the students are developing student run enterprises to help the school become self-sustainable They have opened a bakery and photo and print shop The school is fully accredited by the government as a Technical Education and Training (TVET) school and has been recognized as an outstanding program in the country Phase II of KHA was completed in 2018 adding 3 additional blocks of classrooms, workshop and septic system Construction for the school kitchen is underway and furnishings and equipment have been purchased The dining room will hold up to 400 people and provide meals for the students, staff and events in Valmark Arena The school construction continues to bring much needed work to the community and many of the local people are benefiting from the project and the income it brings to Boneza The purchase of approximately 20 acres of agricultural land near the end of the year will allow KHA to offer a curriculum in agriculture in 2020 and provide fruits and vegetables for the school to become self-sufficient and sustainable
