28 In 2018 Delta Sculling Center ran five major programs our Masters sculling program for adults aged 23 and beyond, our adaptive sculling program for civilians with disabilities (OarBusters), a similar program for wounded warriors (Freedom Rows Delta Heroes), an indoor rowing program in the public schools (the George Pocock Rowing Foundation Erg Ed Program) and we initiated a year-round sculling team for girls 8th 12th grade (Girls Row Stockton) Approximately 40 Masters athletes formed the backbone of DSC, enjoying the benefits of sculling for themselves but also providing all the volunteer hours (7,116 hours equal to nearly four full-time employees-nearly double last years efforts!) to fuel and grow DSCs other four programs The Masters conducted three Sample Sculling training session (2 Thurs pms and Sat ams each during the Spring and early Summer) in which they introduced newcomers to the sport of sculling They were scheduled to attend an all-day About Boat Safety Course given by the Coast Guard and sponsored by DSC at the Stockton Sailing Club which had to be canceled due to the government shut down on Jan 20th In February they conducted a one-day training for military veterans with disabilities at the Stockton Sailing Club, teaching 12 military veterans (with physical and emotional challenges) how to land row and introducing them to the sport of sculling They also participated in indoor rowing competitions in Redwood City and Sacramento as well as Spring regattas in W Sacramento and Gold River, CA During the summer they participated in a regatta in W Sacramento and also competed in the four-day-long USRowing Masters National Championship Regatta in Oakland There they competed in 7 different events In the Fall they participated in two different regattas in the Sacramento area entering four races in the first one and two races in the latter one For several on our Masters team, this was their first season racing We finished the year with a major world-wide indoor-rowing competition twenty-one of our athletes representing all of our adult programs participated virtually in Concept2s Holiday Challenge to raise money for international non-profits designated by Concept2 They logged a total of 1,827,315 meters (the equivalent of 1,135 miles), finishing 30thof 262 virtual affiliations around the world during the month between the Thanksgiving and Christmas holidays In addition to learning to scull, practicing and racing in our sport, the wounded warriors we worked with participated in other ways in our community They also assisted at our fund-raising events, our semi-annual boathouse maintenance days and various other social events Most importantly, one of them who is becoming an adaptive PE teacher, collaborated with our executive director to put together a presentation about land rowing for youth with disabilities and together they presented it at the 47th National Adapted PE Conference, sponsored by CA Assoc for Health, PE, Recreation & Dance in San Diego in early November This was our year for expanding in a serious way into youth rowing In the summer of 2017, we were notified that a grant proposal we had co-authored with people from two public school systems in Stockton was awarded to us This grant (the George Pocock Rowing Foundation Erg Ed Grant) awarded our schools 20 brand new rowing machines, a specialized curriculum for physical education teachers to teach land rowing in their PE classrooms and also got us a day of instruction from a trainer within the GPR Foundation to train up to 40 of the districts PE teachers The superintendents did not sign off on this grant until December 2017 so the equipment was not delivered and the teacher-training was not conducted until early February 2018 Delta Sculling Center was the community partner on the grant, and it became our responsibility to schedule the equipment to be delivered to various trained PE teachers throughout the two school systems for 1-3 weeks at a time We were also charged to oversee the maintenance and repair of these machines as well as to support the teachers in teaching a subject area which for many of them was very new and overwhelming Seven teachers taught Erg Ed units in their PE classes during the Spring Semester and twelve taught the unit to their PE classes during the Fall Semester One of the teachers, Zeb Gromm, was featured by Ken Mashinchi, Fox 40 TV News https://www.facebook.com/KenMashinchiFOX40/videos/1632571223506983/ In October 2018 we also offered an intensive one-day training to certify eight new PE teachers and to help five previously certified teachers to review their understanding of the skills and the curriculum While the Erg Ed program was taking root, we coached two young women whose rowing program had closed in the middle of their high school rowing careers One of these young women raced at the Southwest Youth Regionals in a single scull and became instrumental in assisting us to establish our girls rowing team, Girls Row Stockton After much recruiting, fundraising and searching for candidates, DSC was finally able to hire a full-time coach to head up Girls Row Stockton and to assist in other aspects of our administration and programming With this coachs assistance we were able to hold three summer camps for girls (two week-long camps and one two-week-long camp), we had 8 and 12 girls in attendance at the first two camps and 12 girls returned for the longer camp Five girls received full tuition scholarships to participate in each of the three camps From these three summer camps and recruiting appearances we made in several schools during the Spring, we were able to pull together a team of eight girls who began practice together Monday thru Friday, 4 15 to 6pm through mid-November The girls team participated in one scrimmage at Lake Merritt, Oakland, CA and in two 5-km head races, the Head of the Port and the Head of the American in W Sacramento and at Lake Natoma respectively The girls team also completed two community service projects under DSCs guidance during the fall season one for our communitys Love Stockton event and the other for the Family Resource Network which serves families of children with intellectual and developmental disabilities At the end of November our junior coach left our position for personal reasons and several of our Masters filled in for her, taking different afternoon practices that fit with each of their schedules in order to keep the team going In February 2018 we were notified that we had won an Up2Us Youth Sports Coaching Grant From this grant we hoped to find a young person in college or graduate school or a recent graduate with coaching experience/interest to asst our head youth coach Despite all our recruitment efforts throughout the year, we finally had to relinquish this grant as few candidates emerged and of those, none was qualified This is a position we still hope to be able to fill in the future We were proud to be invited to and honored at the Pacific Project Heroes Annual Dinner on October 20, 2018 Pacific Project Heroes mission is to provide support to the veterans and first responders that choose to serve our nation and communities so selflessly This organization raises funds to support programs and services like our Freedom Rows Delta Heroes program with the purpose of easing the burden and aiding in the transition back to a successful civilian life Finally, the year ended on a very high note when our executive director was chosen by the national body governing all rowing in our country, USRowing She was awarded its prestigious 2018 Isabel Bohn award for achieving measurable success in expanding rowing opportunities for those with physical and intellectual
