

4a (Code: ) (Expenses \$ 11,254 including grants of \$ 1,000 ) (Revenue \$ 0 ) Live Program - Fueled by our team of over 350, the Warrior Volunteer Force, completes monthly community service projects, such as, bringing a community together to help repair veteran homes, services that assist local veteran centers, consistent service projects throughout the year for a 400 bed Veterans Retirement Home facility that uplifts and maintain the quality of life for hundreds of elder veterans, providing key support teams for two local standdown events assisting over 1400 homeless veterans each year, assembling and delivering hundreds of wheelchairs to those in need, coordinating an annual 6K Veterans Walk event that raises funding for an annual holiday event for hundreds of elder veterans, teams to coordinate and assist with local health fair and military school child support events helping hundreds, and basic assistance support for junior military, Veterans and their families in need.

4b (Code: ) (Expenses \$ 83,021 including grants of \$ 72,400 ) (Revenue \$ 0 ) Food4Warriors Program - The Food4Warriors Program bundles several ongoing projects to serve all those in need within the military and veteran communities, including their families. Within the veterans community, our efforts help the poor, economically disadvantaged, homeless, elderly, disabled, and their children. From hosting food distributions to targeted deliveries and special events providing emergency food and basic needs assistance for eligible active duty, active duty dependents, veterans and their immediate families. Each month, our team travels to 1 of 8 locations throughout the region to provide groceries and assorted assistance items to thousands each year. Via our Food4Veterans project, we support a local partnership with Nutrition Dept. of the U.S. Dept. of Veterans Affairs providing special sacks of hand-selected, approved groceries monthly for veterans who have been identified with food insecurity issues among all 7 of the local VA Clinics. With our Feast4Warriors project, special events are hosted during the holidays and challenging times to support those in need
