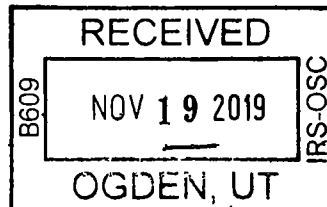

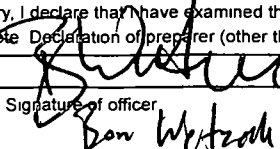

STATEMENT RELATED TO FORM 990EZ, PART III

In the year 2017, the major focus of the Bethel Gridiron Club was to expand the reach of the organization, both in terms of the exposure of the organization to more persons to participate in the organization, but also to expand the exposure of the Organization to outside organizations, specifically youth, neighborhood and scholastic organizations. This focus to a great extent was met in the year 2017 but was expanded in the year 2018. Additionally, the Bethel Gridiron Club obligated itself to provided funding for modifications and upgrades to the athletic facilities at Bethel University, and specifically to the Football stadium and adjoining improvements. The Bethel Gridiron Club also sponsored and held a fundraising and fellowship event in January of 2018 with great scuccess and expended much time and effort in the planning and preparation for a similar event in January of 2019, which event was more successful, provided more support and included much greater attendance than the 2018 event. Additionally the Bethel Gridiron Club provided suuport for the acquisition of specialty footwear that was used by the Bethel University footbal team in its 2018 NCAA Division III playoff appearance and participation, to whcih the Bethel University Football team reached the NCAA Division III Quarterfinals.
