Journeys of Compassion Impact Nations conducted 8, 10, and 12 day mission trips in 2018. We took teams of 10-25 volunteers to Philippines, Uganda, India, Guatemala, Kenya, Puerto Rico, and Bulgaria. On these trips, the teams helped in medical clinics, distributed water filters, provided education in health and sanitation, and taught local pastors and leaders. The teams also led in many evangelistic meetings, conducted door to door evangelism, and baptized new Christian believers.

IThirst Water-borne diseases lead to a multitude of serious health problems, many life-threatening. Impact Nations provides water filters and water tank systems that supply ongoing clean water to families and communities. These solutions along with sanitation and health training result in an immediate, drastic improvement in health.

Sewing School Our Partners, the New Life City Foundation, began a sewing school in India this year. Women are marginalized and often abused by family members before being left alone on the streets to fend for themselves. In addition to annual statements, periodic reviews will be conducted on (a) compensation and benefits and, (b) partnerships, joint ventures,

and any management arrangements, to ensure conformity to our written policies and proper documentation

Lastly, board members can present any conflict of interest concerns at the quarterly board meetings

Part VI 15 - Compensation from the organization is precluded by board members voting on matters pertaining to that employee's compensation

All compensation decisions are made by the Board of Directors

Further, all compensation paid will be reasonable and based on the following factors (a) the type and amount of compensation received by

others in similar positions, (b) the compensation levels paid in our particular geographic community, (c) the amount of time the individual spends

in their position, (d) the expertise and other pertinent background of the individual, (e) the size and complexity of our organization, and

(f) the need of the organization for the services of that individual

Part VI 19 - The organization's governing documents and financial statements were available to the public upon request throughout the tax year
