 The Adolescent Girls Program (AGP) benefited 2,735 adolescent girls and boys, parents, and teachers in 2018. The program aims to promote gender equality and girls' education through life skills, SRHR, and leadership trainings; school scholarships; counseling; parent and teacher engagements; school outreaches; advocacy events; and mass campaigns for boys and girls. The trainings focus on topics such as: self-esteem and body image, puberty and menstruation, and violence against girls with the goal of empowering girls to achieve their full academic potential; become leaders in their schools and communities; and make healthy, informed decisions about their bodies and futures.

4b (Code:) (Expenses \$ 30,144 Including grants of \$ 13,590) (Revenue \$)
 The Big Sisters Network aims to create the space, environment, and time for emerging girl leaders to build their self-confidence through knowledge and skills building, and positively transform their lives and the communities they serve. The network offers additional leadership training, mentorship, and support to alumni of the AGP training program to enable them to stay involved and engaged after they have graduated from the training program. 80 girls were directly served in 2018 through leadership training and support in conducting school outreaches and advocacy.

 The Young Women's Economic Empowerment Program (YWEEN) aims to enhance the economic empowerment of young women, ages 16 to 35 years, so they can become economically self-sufficient, build their confidence, and improve their overall well-being. The program supports and mentors young women to develop their business ideas; learn new vocational, entrepreneurial, and personal development skills; and join a community of supportive women. The YWEEN consists of business trainings, vocational training, and a social enterprise. In 2018, 57 young women directly benefited from the YWEEN.
