28 1 The year 2018 was again filled with program service accomplishments. However, because of illness and surgeries of the President of the Foundation, only 10 program events were hosted by the Foundation for 2018. Partnerships continued to be developed throughout the tri-state communities we serve. The Foundation helped to host Ducks Unlimited Banquet, conducted Bunny Bag Sales at the Sunshine Thrift, sponsored the 2nd annual Tractor Show and Rodeo, the 4th annual Haigler Dundy Roo Spring Arts and Crafts Festival at the Cornerstone Center for Community Service, Memorial/Alumni weekend events, 4th of July celebration, hosted the Dundy County Pre-Fair BBQ at the Cornerstone Center, brought back the Haigler Summer Music Festival in the Park, held the 11th Annual Haigler Fall Tumbleweed Festival, hosted the 5th annual Haigler Gun and Craft Show, and sponsored the 4th annual Winter Holiday Festival. One of the most popular and successful community events was the 4th annual spring Dundy Roo Festival. Billed as a Festival Extraordinaire and the best darn Art, Craft, Wine & Brew Festival. Over 40 artists, art guilds, crafters, and vendors displayed their work. Over 300 people attended the festival. Our tradition of bringing ‘the arts’ to this part of rural southwest Nebraska held true again in partnering with the Nebraska Arts Council and the Museum of Nebraska Art to bring artist John Falter’s paintings to the Festival. The art exhibition remained on display throughout the summer at the Cornerstone Center. 2 The 2nd greatest program service accomplishment focused once again on the annual Fall Tumbleweed Festival held on the Haigler Museum grounds, main street and Highway 34. This was the 11th year for this event and focuses on the Haigler Museums now owned by the Haigler Community Foundation. Work continues on the old Conoco station museum on Highway 34 to refurbish and renovate to become a Nebraska tourist stop. We continue working with other community entities and tourist groups to make this happen. The Tumbleweed Festival has been featured in newspapers and magazines. Over 400 people attend this event, all museums are open, food and drink, musical entertainment, parade, pumpkin decorating, tumbleweed contests, chili-cook-off, games, treasure hunts, and a full day of activities are held. 3 The 3rd greatest program service accomplishment was the 5th annual Haigler Gun and Craft Show held the weekend before Thanksgiving. This event has become one of the most successful and well attended. Over 600 people from at least 7 states viewed the event for 2018. Our rural community and the Haigler Community Foundation are working with tourism groups at the county and state levels to focus on the hunting and fishing opportunities here. The closest gun show held throughout the year is at least 75 miles from Haigler. With at least 20 gun vendors in the gymnasium and 40 craft vendors in suites and hallways at the Cornerstone Center, many displays are available.
