A non-profit organization creating healthier communities by providing fresh, healthy food, nutrition literacy and health and wellness resources. We are committed to developing a cooperative model that can be used in communities where food insecurity and malnutrition exist

Produce to the People

The program includes distribution of fresh produce and nutritious food to members of our community through weekly markets and at no cost to the participants. These farmer's market style distributions run year-round, allowing consistent and reliable access to healthy food for those facing food insecurity. The thousands of pounds of food that are distributed each week come from collaboration and partnerships with Manna Food Bank, local farmers/growers, community gardens, and grocery stores. This year approximately 372,708 lbs of fresh produce was distributed to 9,534 households (29,001 participants) at 252 markets. A 2018 UNCA health and wellness survey indicated a) a local increase in food security - identified by respondents reporting a reduction in the number of meals skipped due to access to fresh produce, b) respondents reported increasing their consumption of vegetables and fruits as a direct result of this access

Rooted in Health

All classes and support are available to participants at no cost. This program uses an evidence based whole person health model that provides education and resources to address the emotional, mental, and physical well-being of those participating. Weekly classes, as well as individual and group health coaching are offered. Bounty & Soul creates a supportive and safe environment in which positive changes in diet and lifestyle are built on relationships and trust. Approximately 7,242 people engaged in the 420 yoga, exercise, and health, wellness and nutrition classes provided. The 2018 UNCA health and wellness survey respondents reported increased knowledge in healthy eating, increased physical activity and energy, improved overall health, reduction in medication taken, improved ability to manage stress, improved weight management and improved feelings of belonging and social connections. Health Coaching element: 100 people attended 48 group classes and 16 individuals engaged in a 3-month one-on-one coaching program. The individualized health coaching focuses on guiding the participant to reach health and lifestyle goals while providing accountability and support. Reported results: weight loss in those seeking that outcome, reduction of A1C in clients w/pre-diabetes and diabetes, decrease in blood pressure & cholesterol in those seeking that outcome, reduction of stress, anxiety & depression

Latinx Engagement

All classes and support are available to participants at no cost. A unique program addressing the needs and gaps in service that exist in the Latinx community. The program includes English as a second language classes, health and wellness classes delivered in Spanish, recipes translated into Spanish highlighting healthy food, culturally appropriate cooking demonstrations, Zumba classes, and access to specific community resources. Zumba: approximately 825 total attendees in 51 classes. ESL: approximately 360 total attendees in 45 classes. Health & wellness: approximately 750 total attendees in 50 classes

The Green Apron Club A collaboration between **Bounty & Soul**, Owen Middle School and YMCA's afterschool program. **Bounty & Soul** provides a 12-16 week experiential learning curriculum for an average of 12-15 middle school students in an afterschool "club" that focuses on healthy cooking, nutrition and mindfulness. Students participate in interactive nutrition lessons paired with a hands-on cooking experience. They learn basic knife and cooking skills and apply their knowledge by preparing a healthy recipe each class. Toward the end of the semester, students travel to a local farm where they learn/experience where their food originates. At the conclusion of the program, each student is given a Bounty & Soul green apron, a binder full of nutritious recipes and handouts and the knowledge and skills to create life-long healthy habits for themselves and their families.

These classes take place during our markets, while parents are involved in the health and wellness lesson. We engage the kids in healthy meal preparation, nutrition education, physical movement and mindfulness. These classes build children's knowledge, skills, self-esteem, confidence and teamwork in a safe and empowering way that will hopefully pave the way for life-long healthy habits
