One award in the amount of \$10,000 was made in support of the Divot Derby, an annual junior golf tournament held for the youth of Escambia County and Santa Rosa County in Florida. The second award in the amount of \$15,000 was made in support of cost incurred to update their new headquarters and minnie golf facility. The facility is the First Tee of NW 's permanent home.

This award was made to the Sacred Heart Foundation in direct support of the new Studer Family Children's Hospital at Sacred Heart. Construction of the new facility is ongoing and expected to be completed in the Spring/Summer of 2019. Supporting the new Children's Hospital is a key initiative for the Bubba Watson Foundation as the needs of the community have outgrown existing resources. When completed, the new Children's hospital will have a tremendous positive impact on the quality and availability of care available to children and families across the entire gulf coast region.
