Line 31 Other Program Services (Total 5,038, which includes 1,209 in grants)

In addition to Spring Rain's three main areas of service (listed in Part III lines 28, 29, 30), our field staff also provides teaching to families and individuals in India. This teaching helps impoverished families and individuals in India live a better, healthier life.

Expenses and grants reported on Line 31 represent the costs of delivering this training.

Teaching topics include: 1) Health and nutrition 2) Basic medical care 3) Biblical parenting, marriage, and family life 4) Respect and protection of girls and women 5) Career development and educational/vocational planning 6) Basic computer skills

In addition to these programs in India, Spring Rain occasionally performs educational activities in the USA related to our work in India.

In 2018 Spring Rain mailed a copy of a book to our entire USA mailing list highlighting the current needs and conditions in India.

Line 31 includes the cost of this mailing. Cost was 403.
