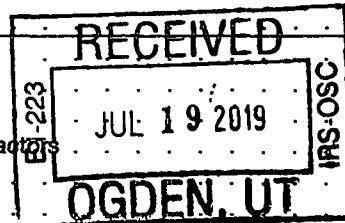



Part III, Line 28 Core free services of our program include door-to-door transportation to medical appointments; transportation and assistance with grocery shopping; friendly visits; and reassurance calls. In 2018, volunteers provided 666 rides to medical appointments, made more than 230 trips to the grocery store, and placed over 852 reassurance calls in service to 530 seniors in need of a helping hand.

Part III, Line 29 The services we provide to seniors in our community are free because we manage a robust program of volunteer recruitment, training, retention, and management. Cultivating and retaining a single volunteer is a task that requires many hours; the challenge to maintain a volunteer corps capable of meeting the ever-growing demand for our core services is great. It involves engaging community partners, raising awareness, and employing ongoing motivational techniques. Additionally, we have invested a great deal of time and money in our powerful scheduling tool to ensure effective communication and maximum efficiencies in providing these services. The return on these investments is great; in 2018 our program's 226 volunteers contributed 3,264 hours of service valued at more than \$83,000 to our community.

Part III, Line 30 Our Honey Do Crews program provides minor home repairs and maintenance to seniors in our two county service area with a priority on projects that enhance their safety and quality of life. We install grab bars; fix leaky faucets; repair/replace door locks; do major yardwork; repair ramps, decks, steps, and porches; construct safety handrails; and more - all with volunteer power. In 2018, our Honey Do Crews completed 53 projects in 613.25 service hours, at an average cost of less than \$72 projects.
