Explanation of "Other Expenses", line 16 of Form 990-EZ: The L3 Foundation purchases and sells de minimus merchandise containing the L3 Foundation logo and information about our organization to encourage awareness and for name recognition in the community. The L3 Foundation leases a storage unit for a minimum monthly fee to store the merchandise and equipment used for our fundraising activities.

Explanation of "Grants & Similar Amounts Paid, line 10 of Form 990-EZ: The L3 Foundation donates funds for medical research to find a cure for childhood cancer as well as assisting families who have children with cancer. In 2018 we donated to numerous families and organizations, including \$10,000 to assist a family with medical expenses; \$5,900 to pay for a child's funeral who was a victim of childhood cancer; \$12,000 to send numerous childhood cancer victims to a summer camp for children with cancer; \$6,700 toward fulfilling a Make a Wish trip for a terminal cancer victim. In all, we donated approximately \$45,000 toward these causes.
