

**Coaching Certification Seminars**

In 2018 we provided a Football Coaching Seminar and Lacrosse Coaching Seminar exclusive to service members of all branches of the military who are active duty, retired, veteran, transitioning or wounded, ill or injured.

Each Seminar prepares participants to begin coaching their sport. Each Seminar is 28 hours of instruction spread over three days. Participants only pay a percentage of the hotel cost which is never more than \$60 per night.

Participants receive the following benefits at no cost: instruction from top tier professional coaches, A Soldiers To Sidelines notebook, information packet, writing and drawing utensils.

Soldiers To Sidelines Under Armour coaching polo shirt, 2 catered evening coaches socials, 1 catered opening reception, 1 catered farewell reception, 3 breakfasts, 2 boxed lunches, and a coaches whistle.

In 2018, thirty four service members attended our seminars. Each participant receives a certificate of completion.

Soldiers To Sidelines successfully achieved the objective to provide a renewed sense of purpose and belonging for service members upon leaving the military.

Many of the expenses for our seminars are itemized under the category "Conferences, Conventions, and Meetings" in Part IX line 19 due to the nature of the seminars.

**Youth Sports Skills Clinics**

In 2018 we provided a free youth football skills clinic and a free youth lacrosse skills clinic. These clinics cap off the seminar weekend so seminar participants can practice what they learned.

Young athletes receive a free T-Shirt, and instruction from local professional coaches and Soldiers To Sidelines Coaches.

In 2018 approximately 100 kids attended our youth clinics.

The objective of the youth clinics is to provide expert instruction for sport technique in the athletes respective sport which is accessible to underprivileged families.

Additionally, the clinics serve as a way to spread awareness among the community that service members make great coaches and should be hired locally.

The final objective of the clinic is to provide coaching practice to service members and create long lasting bonding experience.

**Continued Education Programs**

The Continued Development Programs are web based and small group curriculums that further develop the skill sets for service members to become master coaches.

The Continued Development Programs last approximately 7 months and comprise of 14 interactive exercises focusing on different aspects of coaching.

Participants refine their skills in communication, emotional intelligence, methods of inspiring, methods in motivation, self awareness assessments, learning styles, and teaching strategies.

Additionally, participants refine their skills understanding sports technique, programming, and strategy.

Expenses consist of web interfacing platforms, Cognitive Peak Profile Assessments, and program instructor fees.

**Part III) Soldiers to Sidelines Program Services mainly include 5 services 1) Free Coaching Educational Certification Seminars for Several Sports**

2) Free Youth Skills Sports Clinics, Continued Education Programs, Job and Internship Procurement Services and our Annual Golf Outing These service require time and funds to operate effectively

These service require time and funds to operate effectively Each of these services are either complete free or extremely discounted for the community and service members

As result our primary source of funding comes from contributions and grants Below are some itemized lists of the major expenses for each of these services Since we provide services for our clients

**One of our biggest expenses is paying key people to develop, execute, and manage the content and process of each of these service**

A) Free Coaching and Educational Certification Seminars Each seminar is about 28 hours long over three nights and 2-5 days It typically concludes with the Youth sports skills clinic

The primary objective of these seminars is to inspire and motivate service members to want to achieve mastery in coaching We are providing them with a renewed sense of purpose in a tribe where their military

experience and training directly translates to the work force We give them hope that their new purpose will greatly serve and impact the community

Our biggest expense is compensating the right people to successfully achieve these objectives At the moment, the Executive Director Harlaan Bernstein, has created

the bulk of the content presents the vast majority of content and organizes and manages all operations essential to delivering the ultimate inspirational motivational and educational seminars

In 2018, The majority of executive director compensation was allocated to the creation and execution of each of these program services and mainly for the seminars

Other key expenses for the seminar are hotel costs for participants (we only require participants to pay \$10/night for their hotel stay when many of the hotels charge over \$200/night) The only reason we charge any money at all is to ensure participants show up

Food beverages and catered a table for participants comprise of much of the expenses listed in the program costs in Part VII of form 990 During these times is when participants begin to bond and form their new tribe within Soldiers to Sidelines

Many times we are fortunate to have the use of facilities donated to us which cost on average \$200/hour At 28 hours per seminar this cost can amount to \$5,600

**The third biggest program expense is the cost of apparel and supplies given to participants for free so they can properly complete the seminar**

B) Free Youth Sports Clinics The objective is to provide free coaching to underprivileged communities instructed by local expert coaches and Soldiers to Sidelines military coaches

The youth sports clinic serves as applied practice opportunity for everyone who recently completed the coaching seminar Our top expenses for this program are compensation to the clinic director field space insurance and apparel

C) Continued Education Program (CEP) After service members complete the seminar weekend we encourage them to continue developing their skills to gain coaching mastery

Service members can choose to join our continued development program at 70% discount or for free if they volunteer for Soldiers to Sidelines in the future The CEP is a 7 month long program which delivers

two assignments per month via email and an online platform that requires a few hours of work and thought The program is guided and facilitated by the executive director and the sport director

**The majority of this cost is compensation for the program facilitators and the technology platform to deliver the content**

d) Internship and Job Procurement Services After service members complete a seminar we work tirelessly to find them a coaching position This is requires many hours of making phone calls

reviewing and editing resumes and interview preparation guidance In addition to procuring coaching jobs we facilitate the job acquisition at careers that support service members coaching

e) Golf Outing The Influence to Victory Golf Outing supports Soldiers to Sidelines and is the primary fundraising event There is a committee of volunteers who independently

govern and oversee the fundraising efforts We pay a subcontracted company, Mike Taylor and Co , to organize and operate the golf outing

Mike Taylor and Company receives \$14,000 to raise funds to support the charity and the golf outing The event is wildly successful and provides the additional benefit of connecting our

Soldiers To Sidelines Alumni directly with our corporate sponsors This gives our sponsors opportunities to personally feel the impact of their contributions

and provide networking opportunities for our alumni to potential get hired by our sponsoring companies Funds raised from the golf outing directly benefit and fund the

other program services provided by Soldiers To Sidelines.
