Coaching Certification Seminars

In 2018 we provided a Football Coaching Seminar and Lacrosse Coaching Seminar exclusive to service members of all branches of the military who are active duty, retired, veteran, transitioning or wounded ill or injured.

Each Seminar prepares participants to begin coaching their sport. Each Seminar is 78 hours of instruction spread over three days. Participants only pay a percentage of the hotel cost which is never more than \$600 per night.

Participants receive the following benefits at no cost: Instruction from top tier professional coaches. A Soldiers To Sidelines notepad, information packet, writing and drawing utensils.

Soldiers To Sidelines Under Armour coaching polo shirt, 2 catered evening coaches socials, 1 catered opening reception, 1 catered farewell reception, 3 breakfasts, 2 catered lunches, and a coaches welcome.

In 2018, thirty four service members attended our seminars. Each participant receives a certificate of completion.

Soldiers To Sidelines successfully achieved the objective to provide a renewed sense of purpose and belonging for service members upon leaving the military.

Many of the expenses for our seminars are itemized under the category "Conferences, Conventions and Meetings" in Part IX line 19 due to the nature of the seminars.

Youth Sports Skills Clinics

In 2018 we provided a free youth football skills clinic and a free youth lacrosse skills clinic. These clinics cap off the seminar weekend so seminar participants can practice what they learned.

Young athletes receive a free T-Shirt, and instruction from local professional coaches and Soldiers To Sidelines Coaches.

In 2018 approximately 100 kids attended our youth clinics.

The objective of the youth clinics is to provide expert instruction for sport technique in the athletes respective sport which is accessible to underprivileged families.

Additionally, the clinics serve as a way to spread awareness among the community that service members make great coaches and should be hired locally.

The final objective of the clinic is to provide coaching practice to service members and create long lasting bonding experience.

Continued Education Programs

The Continued Development Program are web based and small based curriculums that further develop the skill sets for service members to become master coaches.

The Continued Development Program last approximately 7 months and consists of 14 interactive exercises focusing on different aspects of coaching.

Participants refine their skills in communication, emotional intelligence, methods of inspiring, methods of motivation, self awareness, assessments, learning styles, and teaching strategies.

Additionally, participants refine their skills understanding sports technique, programming, and strategy.

Expenses consist of web interfacing platforms, Cognitive Pink Profile Assessments, and program instructor fees.

Soldiers To Sidelines Alumni directly with our corporate sponsors. This gives our sponsors opportunities to personally feel the impact of their contributions

and provide networking opportunities for our alumni to potentially get hired by our sponsoring companies. Funds raised from the golf outing directly benefit and fund the

other program services provided by Soldiers To Sidelines.

Prior to completing form 990 the entire executive board (Executive Director, Treasurer, and Secretary) review in detail all expenses and revenues at the year end review board meeting in February.

After this meeting the balance sheet is updated, the itemized cash flow statement is finalized, and all financials are ready to be sourced for the Form 990.

Compensation is determined for Executive Director by the other two board members, Treasurer and Secretary. They decide on amount based on the number of projected seminars

delivered for the year, the number of participants certified through the program, and the amount of projected revenue for the year. Upon determining this number they must vote unanimously to

in favor of the compensation in order for it to take effect. All compensation has been issued as contracted services and the issued 1099 Forms depict these amounts.

Our Conflict of Interest policy is clearly stated in our by laws. We review these terms at our board meetings when making decisions that may result in a conflict to ensure that no conflict of interest occurs.

Part VIII) Compensation to the executive director for program service is approximately 2/3 of total compensation. This is reflective of the amount of time, energy and unique expertise

required to fulfill our program services with highest quality. One third of total compensation was spent on managerial duties corporate stewardship.
