IS A TECH COMPANY WHO WAS GROWING QUICKLY AND GAINING MOMENTUM. THE COMPANY WAS INTERESTED IN LOCATING IN DOWNTOWN OMAHA AND EXPECTED TO EMPLOY A FEW HUNDRED PEOPLE WITHIN THE FIRST FEW YEARS. NORMALLY IN A SITUATION LIKE THIS, THE NEBRASKA DEPARTMENT OF ECONOMIC DEVELOPMENT WOULD OFFER INCENTIVES TO BRING THIS TYPE OF PROJECT TO THE STATE.
