During the year, the Dialysis Center provided almost 33,000 outpatient hemodialysis treatments, and more than 5,000 dialysis treatments were provided to hospital inpatients. In addition, the Dialysis Center participates in research programs related to kidney disease and treatment. Employees are encouraged to participate in local and national organizations which foster advancement in renal dialysis.
