The receipt also states that any grant funds not used or misapplied to another project must be returned to the Friends of Oakland Foundation. The grant recipient also agrees to provide the Friends of Oakland Foundation with progress reports. Each grant is assigned to a member of the Foundation and that member follows up on the grantee's progress.
