AFTER EXERCISING DUE DILIGENCE, THE BOARD SHALL DETERMINE WHETHER MOPS CAN OBTAIN, WITH REASONABLE EFFORTS, A MORE ADVANTAGEOUS BUSINESS TRANSACTION OR OTHER FINANCIAL ARRANGEMENT FROM A PERSON OR ENTITY THAT WOULD NOT GIVE RISE TO A CONFLICT OF INTEREST.
