AMURTEL works with women and children struggling to survive, by providing education, medical care, options for food security such as training in improved farming techniques, micro credit, self help groups, literacy training, etc. to help women become financially stable. Our approach is to partner with and empower those we work with, encouraging self-initiative and self-determination. We also provide immediate relief to families in the form of food, water and medical care after a disaster.

AMURTEL had designed and built Solar Outreach Systems (SOS) trailers to be sent to Puerto Rico after Hurricane Maria hit in the fall of 2017. These units were used in low income areas that had no power, and provided the communities with a way to recharge cell phones, laptops, and other small appliances, as well as purified 600 gallons of water a day. 4 other SOS units were built but kept State side after power was restored to the Island.

4b (Code:) (Expenses \$ 60,769 including grants of \$ 60,583) (Revenue \$ 52,339)

AMURTEL supports programs that help over 1000 teenage girls develop skills and healthy options to get out of poverty, supports 400 women with Micro Credit, pays the salaries of community organizers to run the aforementioned along with organizing Self-Help groups for over 1000 women living in unrelenting poverty. We provide support for a children's home of 28 children, ranging in age from 2 weeks to 12 years, and three schools with a combined total of 850 students, all from homes experiencing deep poverty. Our program are in Port au Prince, Banan, and Anse a Pitre, and also include literacy and agricultural training for the women.

In India, AMURTEL supports schools and homes for girls in rural West Bengal, in an area considered one of the poorest within India. We are also working to build a college for girls in this area, as education is one of the most effective ways to help girls and children in general break the cycle of poverty too many are born into. We are also supporting the construction of a hospital in Kolkata that will have a special focus on women's health issues.
