The grants awarded in 2018 were to support and train 500 youth from low-income rural communities through a series of training programs, workshops and exchanges.

This service agreement was for the supervision and oversight of SERES Global's grantee partners in country, as well as the creation of new partnerships and investigation into further collaboration opportunities.

Disaster relief and disaster recovery funding for Fuego Volcano eruption
