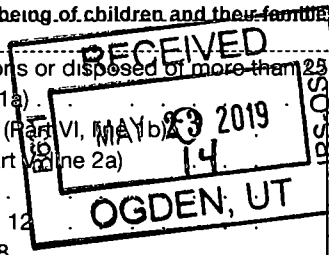

During the summer of 2018, The Bennett Foundation and iamtheCODE launched their Academy in Senegal which combines sport and coding. Free to the public, the Girls Empowerment Summit inspired girls to break through barriers of sexism and conquer inequities, both personally and collectively. This program engages high-school-aged, female-identified youth in interactive workshops and activities and highlight activism for equity, building healthy relationships, and careers in Science, Technology, Engineering, Arts, and Math (STEAM) fields

The Farm to ECE program was designed to help create a culture of wellness for teachers, preschool students, and their families. The goal is to help children understand why nutrition is important, what nutritious food looks like, where food comes from, and how our behaviors affect the land, plants, and animals that sustain us all. In partnership with the Honolulu Community Action Program, a pilot cohort model was started to include 24 Head Start classes, 53 teachers and assistants, 10 family advocates, and 3 administrators from health team. 480 students and families reached through this intervention. Additionally, Monthly training (1st Wednesday of each month) and Nutrition lessons, field trips, community speakers were scheduled along with classroom support visits (each site minimum of 1x/month)
