Provide opportunities & support for short term mission trips. Support ongoing education support of orphans, missionary families, and for families at mission hospitals.

 Financial support provided to Tumaini Childrens home, a non profit corporation in Eldoret, Kenya. Funds used to provide for the daily needs of 33 orphaned children, including food, clothing, shelter, education, & medical care. A new home was completed to adequately house the children as required by the Kenyan government. Donations in 2017 & 2018 funded the entire construction. The house is managed by missionaries Horace & Phyllis Leister. The childrens home employs a staff of 11 Kenyans including 3 certified teachers. These employees care for the children 24 hours/day, and a few assist with farming, raising crops consumed at the childrens home.
 The only overhead type expenses associated with the childrens home were wire transfer fees for sending funds from a US bank to a bank in Kenya.
 Tumaini childrens home will continue to be supported by Family Keys International. A home for another missionary family is under construction on the childrens home 10-acre compound. The school will be expanded as the number of school age children increases.

4b (Code:) (Expenses \$ including grants of \$ 37,240) (Revenue \$)
 Financial support provided to missionaries Horace & Phyllis Leister for subsistence and personal needs. Horace & Phyllis manage Tumaini Childrens Home. Funds for Tumaini Childrens Home cannot be used for Horace & Phyllis's personal needs per rules of the Kenyan government and guidelines of the childrens home non-profit organization. Funds from Family Keys International were used for food, clothing, medical expenses, and their travel to the US.
 Family Keys will continue to support Horace & Phyllis Leister in coming years.

 Financial support provided to missionaries Josh & Rachel Leister for subsistence and personal needs. Josh is a volunteer surgical assistant at a hospital in Kapsowar, Kenya. Rachel is a nurse and home schools their 4 children. Rachel also helps with the education of children at the hospital complex and at Tumaini Childrens Home. Josh also does mission outreach work in rural areas of eastern Kenya.
 Family Keys International will continue to support Josh & Rachel Leister, and their family, in coming years.
