Sinjar Outreach: The projects targets displaced families that have taken up residence in various locations on top of Sinjar Mountain, as well as those who are returning to their homes which sometimes were destroyed in villages on the north side of Sinjar and trying to rebuild their lives. Yazda provides winterization, development, and aid to these families.

4b (Code:) (Expenses \$ 98,000 including grants of \$ 100,000) (Revenue \$)

Social Service Program & Women's Psychological Support for Female Survivors of IS Enslavement: This program was established to help take care of the abused and frightened women from ISIS attacks. The program is staffed with multiple case managers to help the women begin a new safe life after going through the horrific attacks and abuse on their families and themselves. Yazda reaches out to walkins and to the women that are living in abandoned buildings in the surrounding area. Yazda also has a therapist on staff for those women who would like to take advantage of the service. The therapist is available on an individual and group basis. Also, As funding allows, Yazda provides food and clothing to survivors, and organizes pilgrimages for women and girls to the holy village of Lalish, where the Yazidi spiritual leader Babasheikh speaks an affirming message of acceptance to the survivors, emphasizing that they are valued members of the community.

Small Businesses Project for Refugees who returned to their homes: Yazda in partnership PLC started many small businesses in Northern Iraq for refugees who had returned recently to their homes, in order to vitalize the local economy and help decrease the number of refugees in Camps. As external support can always help stabilize the local economy and the presence of more businesses in Shingal may also serve to buttress returnee numbers that have previously remained low due to lack of services and supplies in the region. Therefore, Yazda has designed an intervention to support small business development to meet the needs of the community.
