 NWDP rescued 139 dogs and adopted 130 in 2018, compared to 136 and 129 respectively in 2017. Our numbers did not significantly increase this year due to our facility being contaminated with Parvo, a highly contagious virus, and having to close our puppy in-take until areas were properly dealt with, which took major construction. We also took in many more medical cases and senior dogs in 2018 than in previous years.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$)
 Our Senior Sanctuary Program has over doubled in size. We rescued 19 Senior Dogs in 2018. 12 were adopted, 2 passed away, and 5 remain with us at the sanctuary. We also implemented a community program with our senior dogs called "Seniors for Seniors" and take groups of our senior dogs to a memory-care facility to visit with the residents. We look forward to growing this portion of the program in 2019.

 We continue to partner with other area resources to provide free and low-cost spay/neuter, as well as other medical care that is needed for dogs in low-income families. This initiative has allowed us to help keep dogs out of the shelter system and in their homes with their families. We also continue to donate funds to programs such as BAPBR, "Snip Your Pit," and Love Leo Rescues mobile spay/neuter clinic to support what we consider to be the core of the issues, spay and neuter.
