In response, TransLifeline removed these officers access to the organization's bank accounts and assets, placing them on suspension while the organization conducted an initial investigation. The findings of this investigation resulted in the termination of the officers employment and marked the starting point of the asset recovery process, for which the organization retained legal counsel, the services of an independent bookkeeper, and the services of an independent accounting firm. In addition to the amount declared as an excess benefit transaction on the organization's 2017 990, the organization believes that the officers made unauthorized purchases totaling \$58,102 during the 2018 fiscal year. While the organization was able to recover a portion of the organization's assets from the terminated officers, it was unable to recover the full amount of assets and diverted funds without full cooperation from the terminated officers. On June 28, 2018, the organization and the terminated officers entered a mediation where the terminated officers agreed to return the diverted funds over a period of time not to exceed ten years. It is the organization's assessment that the terminated officers are financially unable to immediately return the diverted funds. The organization believes that its best chance at recovering these funds will be to enforce the agreement to recoup the diverted funds over the next ten years. However, if the repayment agreement is not honored, the organization is prepared to pursue all appropriate legal actions in order to recover the diverted funds.</p>
