Part III - Fond Blanc Foundation was established in 2015 to support an orphanage in Fond Blanc Haiti. It is an all volunteer organization - there are no paid staff. The orphanage is operated in partnership with a local church in Haiti that established the orphanage following the earthquake. Fond Blanc Foundation provides the funds to ensure the children are well-fed (chicken or some kind of protein at least twice a week), clothed, and have a chance to go to school. Teacher salaries and schools supplies are supported by the Foundation.

Part III - 4c In 2017 torrential rains from a hurricane washed out the only road leading to the orphanage in Fond Blanc. Because of limits on the government's ability to respond to all the damage across the island, a Go-Fund-Me fund-raising campaign was launched in late 2017 to raise funds to restablish the road that carries all supplies and other necessities to Fond Blanc. \$72,400 was carried over to 2018 for the project. The road was completed in February 2018. This was a one-time project.

Part III - 4d The balance of the funds that were not sent for direct services to the children were spent on maintaining a website, fees for collection of monthly child sponsorships, wire transfer fees, fund-raising expenses and mailing list maintenance.
