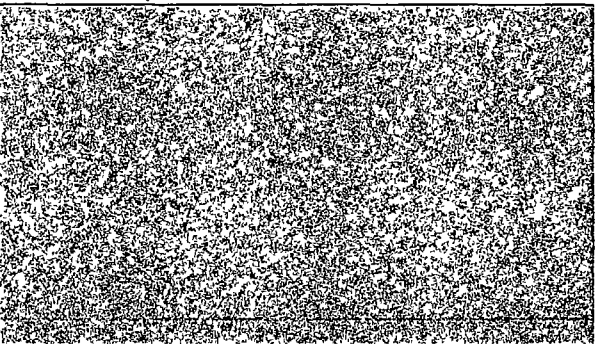

The securities portfolio which created the endowment consists of publicly traded investments and a cash account managed by

UDS as directed by board resolution and consequent agreements

The purpose of the investment is to generate a steady and reasonably predictable revenue stream to support the organization in

perpetuity. In general, revenue is capitalized to restricted assets each year and 4% of the three-year rolling average is released to the

organization each year. Of that balance, 25% is available for administrative purposes with the balance being used for the goals of the
