THE ORGANIZATION WORKS TO END THE HARMFUL PRACTICE OF SEPARATING CHILDREN FROM THEIR FAMILIES AND RAISING THEM IN AN ORPHANAGE. THERE ARE AN ESTIMATED EIGHT MILLION CHILDREN GLOBALLY LIVING IN RESIDENTIAL INSTITUTIONS (SOMETIMES KNOWN AS ORPHANAGES) THAT SERIOUSLY HARM THEIR HEALTH AND DEVELOPMENT AND REDUCE THEIR LIFE CHANCES. MORE THAN 80% OF THESE CHILDREN ARE NOT ORPHANS BUT HAVE AT LEAST ONE LIVING PARENT. MOST ARE PLACED IN INSTITUTIONS BECAUSE THEIR FAMILIES ARE POOR, OR BECAUSE THE CHILD HAS A DISABILITY AND THERE ARE NO COMMUNITY-BASED INCLUSIVE HEALTH AND EDUCATION SERVICES. WE WILL ALSO CONTINUE DEVELOPING RELATIONSHIPS WITH ORTHODOX CHURCH AND GREEK NGOS TO ENCOURAGE REFORM AND BREAK DOWN STIGMAS SURROUNDING DISABILITY. FINALLY IN UKRAINE, WHERE THERE IS THE HIGHEST NUMBER OF CHILDREN IN INSTITUTIONS IN EUROPE, WE WILL SUPPORT THE AUTHORITIES TO IMPLEMENT THE NATIONAL DEINSTITUTIONALISATION STRATEGY WHICH LUMOS HELPED TO DEVELOP. 2. NEW FRONTIERS WITH AT LEAST EIGHT MILLION CHILDREN WORLDWIDE LIVING IN INSTITUTIONS, IT IS CRUCIAL THAT WE EXPAND BEYOND EUROPE. BY SUPPORTING US AS WE GROW PROGRAMMES IN AFRICA, LATIN AMERICA AND THE CARIBBEAN, AND THE MIDDLE EAST, LUMOS USA WILL ENABLE US TO REACH MORE CHILDREN THAN EVER BEFORE, THEREBY HASTENING THE ERADICATION OF THIS FORM OF CHILD ABUSE. IN COLOMBIA, THERE ARE MYRIAD REASONS FOR CHILDREN BEING SEPARATED FROM THEIR FAMILIES, INCLUDING DISPLACEMENT DUE TO CONFLICT, EXTREME POVERTY, AND STIGMA AROUND HIV AND AIDS. IN 2019, OUR COLOMBIA TEAM WILL SUPPORT THE GOVERNMENT TO BUILD A STRONGER SOCIAL INFRASTRUCTURE SO THAT THOUSANDS OF CHILDREN CAN REGAIN THEIR RIGHT TO A FAMILY IN HAITI, THE TOXIC TREND OF ORPHANAGE TRAFFICKING IS PUTTING SOME OF THE WORLD'S MOST VULNERABLE CHILDREN AT RISK OF NEGLECT, ABUSE AND EVEN DEATH. UNSUSPECTING DONORS ARE FUELING A TRADE IN CHILDREN WHICH IS DRESSED UP IN THE NAME OF CARE. OUR HAITI TEAM IS ON THE FRONTLINE OF THIS CRISIS, SEEKING PROTECTION FOR THESE CHILDREN, AND PROSECUTION FOR PERPETRATORS. OUR EXPANSION INTO AFRICA WILL ALLOW US TO SUPPORT CHILDREN AND FAMILIES WHO HAVE BEEN SEPARATED IN KENYA DUE TO POVERTY AND DISABILITY. WE WILL CONTINUE TO BUILD OUT OUR PROGRAMMING AND SUPPORT THE AUTHORITIES IN JORDAN, WHERE CHILDREN WITH DISABILITIES FACE INCARCERATION IN INSTITUTIONS. 3. GLOBAL TRAINING AND ADVISORY SERVICES. GTAS WILL ALSO DELIVER TTS TO LOCAL NGOS, PARENTS AND PROFESSIONALS TO ENSURE THAT CHILDREN ARE PROTECTED AS THEY TRANSITION INTO THEIR NEW LIVES, AND THAT THERE IS THE NECESSARY SUPPORT IN PLACE TO HELP THEM REMAIN TOGETHER. THE HIGH-QUALITY TTS PROVIDED BY GTAS DIRECTLY IMPACTS THE LIVES OF VULNERABLE CHILDREN AND FAMILIES, ENSURING THAT CHILD PROTECTION SYSTEMS ARE STRENGTHENED AND IMPROVED SO THAT CHILDREN ARE NO LONGER AT RISK OF SEPARATION FROM THEIR PARENTS. IN 2019, GTAS WILL PROVIDE TTS TO THE LUMOS COUNTRY PROGRAMMES IN THE USA, EUROPE, LATIN AMERICA, THE CARIBBEAN, SUB-SAHARAN AFRICA, THE MIDDLE EAST AND EAST AFRICA. THE GTAS TEAM WILL FOCUS ON A WIDE RANGE OF AREAS, FROM PROGRAMMES THAT ARE APPLICABLE IN MULTIPLE COUNTRIES, SUCH AS SUPPORTING YOUNG PEOPLE TO LEAVE CARE AND HELPING FAMILIES TO CARE FOR CHILDREN WITH COMPLEX DISABILITIES, TO PROGRAMMES THAT ARE CONTEXT-SPECIFIC, FOR EXAMPLE PROTECTING UNACCOMPANIED MIGRANT AND REFUGEE CHILDREN IN BULGARIA AND ETHIOPIA, AND CHILDREN WHO HAVE BEEN SEPARATED FROM THEIR FAMILIES AT THE US BORDER. GTAS WILL CONDUCT STUDY VISITS BETWEEN COUNTRIES, IN ORDER TO DEMONSTRATE EXAMPLES OF BEST PRACTICE. THESE WILL INCLUDE A VISIT FOR BULGARIAN DELEGATES TO THE UK TO LEARN ABOUT FOSTER CARE FOR CHILDREN WITH DISABILITIES, AND A VISIT TO THE CZECH REPUBLIC FOR DELEGATES FROM GREECE, TO WITNESS DI PROCESSES IN ACTION. 4. RESEARCH. THE OVERARCHING GOAL OF THE LUMOS FOUNDATION'S RESEARCH TEAM IN 2019 IS TO GENERATE 'EVIDENCE FOR CHANGE', THEREBY ENABLING LUMOS TO LEAD THE DEBATE AND TRANSFORM CHILD PROTECTION POLICY AND PRACTICE AROUND THE WORLD. RIME'S WORK WILL CONTRIBUTE TO SIX KEY AREAS: 1) SCALE AND TRENDS. E.G. HOW MANY CHILDREN LIVE IN INSTITUTIONAL CARE AROUND THE WORLD?
