THE GUIDANCE ALSO ENHANCES DISCLOSURES FOR BOARD DESIGNATED AMOUNTS, COMPOSITION OF NET ASSETS WITHOUT DONOR RESTRICTIONS, LIQUIDITY, AND EXPENSES BY BOTH THEIR NATURAL AND FUNCTIONAL CLASSIFICATION.
