Catapult offers the potential of additional financial support to its development grantees in the form of Momentum Grants and Consulting Grants. Catapult grantees may apply for a Momentum Grant for up to \$15,000 when they reach a point in their filmmaking process when an infusion of funds can propel them to their next step. Examples include hiring an editor, getting transcripts translated, archival research, or music composition.

4b (Code:) (Expenses \$ 319,927. including grants of \$ 255,000.) (Revenue \$ 0.)

Catapult's Development Grants provide up to \$20,000 to documentary filmmakers who have a strong story to tell, have secured access, and are ready to create a fundraising piece to help unlock critical production funding. We enable filmmakers to develop their projects to the next level, at the early stage when funding is hard to find. We support powerful and moving storytelling by filmmakers with a strong voice across a broad spectrum of subject matter. In addition to the Development Grant, recipients have access to a mentorship program with the Catapult team, in areas including story development, production process, fund raising and distribution strategy. Catapult's involvement with each project is uniquely tailored to the needs of the filmmakers.

4c (Code:) (Expenses \$ 67,731. including grants of \$ 60,000.) (Revenue \$ 0.)

Catapult also supports SFFILM's Doc Stories festival and recently launched the SFFILM Catapult Documentary Fellowship. Catapult and SFFILM support filmmakers in the early stages of development on compelling, story-driven, feature documentary films. The fellowship includes a \$10,000 grant, curated mentors whose work or artistic approach aligns with the filmmaker's goals, guidance from SFFILM and Catapult Film Fund staff, and access to SFFILM's FilmHouse residency and dynamic suite of artist development services. By funding early development, this fellowship allows filmmakers to create a strong fundraising trailer and core application with which they can seek to bring on additional key team members, partners, and funders. The fellowship is geared towards emerging filmmakers who have directed short films previously and for whom this is their first feature, or for filmmakers who have directed one or two features already.
