**Supplemental Information for Parts III and IV**

The Organization's primary purpose remains as in previous years, to help veterans in need, including the provision of medical transport for wheel chair bound vets to their required medical appointments at the Salem VA Medical Center, some 60 miles from Lynchburg; and to assist deserving vets with support such as finances, food, shelter, filing of VA claims, utilities, rent, and so on. The Lynchburg Area Veterans Council for a second year planned, organized, raised support, and executed a Veterans Day Parade, the second one in Lynchburg in 80 years. Again this year, this was the most expensive program at a cost of \$2939, but out of the funds raised for the Parade \$14,650 was used to fund grants to help needy vets, as shown on Part III Line 28. Another program organized was the 9/11 Heroes Run, to honor the victims, military and first responders on 9/11. The expenses totaled \$1301. Unfortunately, the Organization actually lost money on this event. The LAVC sponsored a Craft Fair, the cost was \$860, and a total of \$779 was used to fund individual grants to deserving vets. Another program listed in Part III, Line 31, is the medical transport of wheel chair bound vets to their required medical appointments. The Organization actually had no costs with this program, and was able to grant a total of \$3050 in support of this program, which was used to transport the vets in qualified professional medical transport commercial carriers.
