28 In FY 2018 the Organization completed approximately 6 Tribal Environmental Summits on the Nez Perce Reservation at the Clearwater River Casino. These had movies, presenters and speakers from across the Pacific Northwest, the United States including Alaska and Canada. Total attendees ranged from 30 to 85 at these events. We also have participated in and worked on the 4th Free the Snake Flotilla. The Organization has complete working on the Nimiipuu Canoe Project which involved carving a dugout canoe with 35 4th and 5th graders coming to work on this every Wednesday. The Organization offers a canoe paddle making class along with the students and adults each week. Additional accomplishments include the expansion of activities the Organization offers to include arts and crafts classes for tribal youth to develop and hone their skills in sketching, painting and woodworking.
