They are ranked in comparison to other applicants in a given area and selected for next steps based on their ranking and the availability of apprenticeship positions in their area. 2) The applicant has a phone screen with Apprenti staff to check that they understand how the program works and what their commitment will be and to confirm their occupational interests so we can match them with appropriate opportunities. We also check for work authorization and verify eligibility for veterans' preference at this time if applicable. 3) The applicant goes through a behavioral interview with Apprenti staff to assess for grit, intellectual curiosity, and collaborative skills. Successful applicants are then eligible to interview with an employer. 4) Employers interview applicants in a 2 : 1 ratio of applicants to position. Selected applicants begin their apprenticeship within 2-4 weeks of selection. Unsuccessful applicants are eligible to re-interview with other employers up to three times.

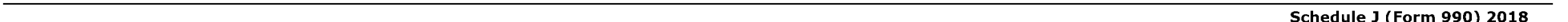
