Street Child is an integrated education and child protection nonprofit which provides catalytic funding and support to local grassroots organizations in communities experiencing an education crisis, empowering and strengthening them to design and deliver rapid re-entry programs, and build systems-strengthening sustainability solutions which underpin access to and success in school. Operating at the humanitarian-development nexus we deliver data-driven interventions that accelerate access, quality, and education outcomes.

Breaking the Bonds - education, employment and life skills / leadership / rights awareness training for young adolescent women of Nepal's Musahar caste. With a 3% literacy rate, life opportunities for this population are limited
In the first six months Street Child registered and enrolled 1,220 girls between the ages of 15 and 18 onto the Accelerated Learning Program. We successfully recruited and trained 40 Community Educators (27 female and 13 male) to be teachers and community advocates. We also designed & developed teaching and learning materials with our education specialist partner Aasaman which are being used by the Community Educators and the participants. We also successfully recruited & trained 40 social workers from within the communities, including running a ten-day residential training course to ensure that all topics from communication style to safe-safeguarding were covered. On completion of their training the social workers launched thrice-weekly Life Skills Workshops in 40 communities and successfully enrolled 1220 girls into this strand of the program. The ALP is 9 months long and the first cohort has not yet completed this, so there have been no transitions as yet into the employment/ entrepreneurship element.
