Received \$150,000.00 grant from the Southeast Sustainable Communities Fund (SSCF) and \$1,000.00 unrestricted grant from the Community Foundation of Greater Huntsville for a "Video Challenge". Both grants were used to upgrade 42 homes with necessary energy upgrades including retrofits such as ductless HVAC systems, window heat pumps, attic insulation, floor insulation, and air sealing measures up to an average per home cost of \$5,000.00. The upgrades were made on HUD qualified low income homeowners and resulted in significant reductions in energy use and costs.
- 4b** (Code: 60403) (Expenses \$ 48,700.00 including grants of \$ 50,000.00) (Revenue \$)
Received \$50,000.00 from the Community Foundation of Greater Huntsville for a Bikeshare Grant. This grant was initiated for greener modes of transportation and health incentives. It provided bicycles in City Parks for the public to use.

Toyota Manufacturing donated \$30,000.00 to the Bottle Caps Recycling Program. Revenue of 1,892.48 was generated from the recycle of bottle caps processed by KW Plastics Recycling. Awards in the amount of \$27,850.00 were given to City schools participating in the bottle cap program. The "Bottle Caps Program" saved over 14 million plastic caps from going to a landfill and resulted in the recycling of plastic to paint cans! The program serves as a great educational tool for the schools to teach recycling, waste reduction, environmental land stewardship.
