In 2018, IndieSpace continued its search for a new, permanent space for indie theater artists and we grew our Advisory and Consulting Program by 15 organizations. IndieSpace maintains contact with its past Advisory and Consulting clients, offering support as needed, on various issues like landlord communication, DOB violations etc. Below are a few of our 2018 success stories -IndieSpace coached The Chain through their space search when their building in LIC was sold and the new landlord wanted to double their rent. Through IndieSpace's network, we were able to pair The Chain up with Workshop Theater, who was preparing to close their two spaces in Midtown. The Chain now leases the larger space that Workshop previously occupied and Workshop maintains the smaller theater. This partnership, created by IndieSpace, preserved two midtown theaters that were likely going to be turned into commercial office space -Educated Little Monsters, a community based arts org in Bushwick, serving children of color, lost their space when their building was sold. IndieSpace facilitated a space search for them, advised on lease negotiations and gave guidance when working with various landlords. Educated Little Monsters signed a new lease and was able to stay in their neighborhood with IndieSpace's assistance -IndieSpace guided JACK in Brooklyn through their space search and lease negotiations. JACK moved into their new space at the beginning of 2019 -IndieSpace provided ongoing support to The Tank and The Chain when dealing with the DOB and the Fire Dept, saving them thousands of dollars in potential, unfounded fines.
